### Rules - Storage in Golf Car Barn

1. Only members in good standing may rent stall(s) in Golf Car Barns for their own use.
2. Member assumes the responsibility to keep stall neat and orderly as possible.
3. Any Hazardous or Environmental cleanup costs (old batteries, paint, and etc.) will be the member(s) responsibility.
4. A member has thirty (30) days to correct notice or any violation or overdue rental fee(s). if corrections not made or fees not paid at end of thirty (30) day period the Board of Directors will make corrective measures which may include disposing of obvious trash, impounding material(s) by staff to termination of the rental agreement and liens set in motion. All costs for such action(s) will be the responsibility of the member.
5. Member must fill out change of Golf Car Rental form if a different one is to be stored in storage stall.
6. Member shall notify the Association office staff in person or in writing of when space is no longer required.
7. Pets must be on leash when in Golf Car storage Barn area and children are to be supervised and not permitted to drive or play in rental area.
8. Violations and complaints are to be reported to the Association office in writing, name of complainant we be kept confidential.
9. Golf Car Storage Stall rental agreement(s) need to be renewed annually.
